- Applications should be sent separately for each subject.

 Suppliers who fail to quote two times / fail to delivery on time in conformity with the order will be deleted from the Registration
- of Suppliers list without giving any notice. The vocational Training Authority has the authority to accept or not the application. Registration will be done after inspection of
- The vocational Training Authority has the authority to accept or not the application. Registration will be done after inspection of the applications and getting any clarification if needed.
 The Vocational Training Authority has authorized power to decide whether the contract is awarded or not as needed. Relevant Organization should process a valid Business Registration obtained from the appropriate authority for each field and certified copies of this document should be attached with the application.
 Incomplete applications without supporting documents will not be considered for registration.
 Registered Suppliers those who are not responded (for bid invitations) two times can be black listed by the Authority.
 All the requested documents and details should be correct and clear.
 The application from for registration are high exhabiting a letter addressing to the chairman wecational Training.
